The Town of Chase City will receive sealed bids for street re-surfacing/paving on Jefferson Street from W. Second Street northward.

The project includes:

- Standard overlay of 1.5-2" applied asphalt from current road edge to current road edge, filling potholes and dips as needed.

Bids are to be priced per ton applied work.

The project is not to exceed \$55,000.00. Work will begin on Jefferson Street at W. Second Street and will continue northward until the project budget is met.

Work is to be completed on or before October 31, 2018. There will be a fine of \$500/day if not completed by October 31.

The successful bidder shall provide all labor, materials, and equipment necessary to re-pave the roadway. Bidder to maintain insurance up to \$1,000,000, listing Town of Chase City as additional insured.

Bid Closing Date and Time: Sealed bids must be received at Chase City Town Hall, 319 N. Main Street, Chase City, VA 23924 no later than 3:15 PM on Friday, August 24, 2018. Faxed or e-mailed bids will NOT be accepted.
